purported to have been made by authority of one who did not give such authority. Defendant is liable under section 562.056(1)(3) RSMo because the conduct constituting the offense was engaged in, authorized, solicited, requested, commanded or knowingly tolerated by a high managerial agent acting within the scope of the agent's employment and in behalf of the corporation.
